Minutes of the Meeting of the Executive Committee of the All India Federation of State Civil/Administrative Service Associations held in the Conference Hall of the Punjab Bhawan, Delhi on 04th January 2020 from 11.30 AM onwards.

In chair: Dr. Jiban Chandra Chakraborty, President, AIF

Names of the participating States: 1. Bihar 2. Chhatishgarh 3. Haryana 4. Himachal Pradesh 5. Karnataka, 6. Punjab 7. Tripura 8. West Bengal

Opening remarks by President: Welcoming all the participating representatives from the SCS Associations, the President of the Federation expressed regrets for holding the meeting of Executive Committee of the Federation after a gap of more than two years. He also noted that although the EC could not formally meet for months together due to several unforeseen reasons. Federation had always been in touch with the SCS Associations and addressed the issues brought to its notice, whether at the Centre or the States, to the best of its capacity. He also observed that Federation derives its strength and sustenance from the SCS Associations and, therefore, it is imperative that the SCS Associations also remain active, stimulant and vigorous regardless of the challenges they face in their States. Recounting the eventful years of the AIF, its achievements and its strong presence in the country's administrative ecosystem where the SCS officers play the most significant role, the President urged all the SCS Association for properly comprehending the contemporary social realities, emerging challenges before the bureaucracy-regulatory and developmental-cutting across the texture of the constituted services and wholeheartedly strive to strengthen the unity of the SCS Associations and add vigour to the Federation in their collective interests. He also requested the SCS Associations to feed the Federation with the information sought for by it at regular intervals to strengthen its data base. While eloquently appreciating the initiatives of Karnataka Administrative Service Association for its plan to organize the centenary celebration of the Association in February/March 2020 in Bengaluru, the President requested all the SCS Associations to join the celebrations in full measure and further consolidate the strength of the Federation that represents the collective will of the SCS Associations.

AGENDA: PART 1: GENERAL

Agenda item No. 1: To confirm the Minutes of the Executive Committee Meeting held on 16th September 2017 at Himachal Bhawan, New Delhi.

The minutes of the meeting held on 16^{th} September 2017 having been circulated via e-mail to all the State Associations, no additions/alterations/changes have been suggested from any of the State Associations, and therefore, the minutes of the meeting were taken as read. Thereupon, the House confirmed the minutes.

Agenda item No. 2: To discuss, deliberate and firm up action-points for the AIF on the centenary celebration of Karnataka Administrative Service in February 2020 as officially intimated to the AIF by the KAS Association as also to take detailed briefing from the KAS Association in that regard.

Discussion: Shri.B.N.V. Reddy, President, Karnataka Administrative Service Association, tracing the glorious journey of the Association during the last 100 years, presented before the house a detailed outline of the programme of the centenary celebrations of the Association slated to be organised in the last week of February or first part of March 2020. Recounting the historical background and contemporary socio-political context of the formation of the Association, styled Mysore Administrative Service Association, in the year 1819 during rule of the Maharaja of Mysore, Shri Nalvadi Krishnaraja Wodevar, with it its eventual transformation into Karnataka Administrative Service Association in the post-independence era, Shri Reddy stated that the Association was all set to make the centenary celebration grand, inclusive and befitting to the mantle it has been carrying and the legacy it has inherited. He informed the House that at the instance of the Association a centenary-logo has been created and ceremonially released recently by the Chief Minister of Karnataka, in a programme organised at the State capital. Similarly, a centenary-Diary containing, among others, the photographs of the colourful 100-year-journey of Mysore Administrative Service Association as well as of Karnataka Administrative Service Association has been released by the Chief Secretary, Karnataka. The President and General Secretary of the Association jointly presented to all the participants in the meeting a copy of the centenary Diary. As regards centenary celebration programmes, the President informed that Sports Meet, Seminars, Symposiums, Development initiatives with inclusive approach etc. were on the cards. He also requested the SCS Associations to offer their suggestions for further enrichment of the centenary celebration programmes. The House was informed that the Association was trying its best to ensure that the Hon'ble Prime Minister of India, important Ministers of the Central Government and other dignitaries attend the centenary celebrations. Based on their availability final date of the inaugural programme would be fixed, the President said. He, however, mentioned that the venue of the Programme will be the grand Karnataka *Legislative Assembly Building* at Bengaluru. The President of the AIF advised the KASA to effectively utilise multiple channels of operation for ensuring the presence of the Prime Minister of India and other important Ministers of the Central Government in the Centenary Celebration as the occasion has a pan-India impact with stimulating effect on the SCS officers across the country. He also requested all the SCS Associations to wholeheartedly participate in KASA's Centenary celebration to make it more colourful reflecting India's unity in diversity and fraternity of the SCS officers of the country.

Decisions: As regards Federation's concrete support to KASA in their centenary celebrations, the following decisions were taken after threadbare discussion and deliberations:

- (i) AIF shall formally request all the SCS Associations to participate in the Karnataka Administrative Service Association's Centenary Celebration once the KASA finalises the date of inaugural programme etc.
- (ii) AIF will hold its next Executive Committee meeting in Bengaluru on the day before the Centenary celebration programme is inaugurated.
- (iii) AIF shall send printing materials for the commemorative souvenir to be brought out by KAS Association on the occasion of its centenary celebration.
- (iv) AIF shall release a full page (Back Page) advertisement for the commemorative souvenir.
- (v) AIF shall make every effort to make the centenary celebration programme a grand success in terms of participation from the SCS Associations as well as its own participation in the whole programme.

Agenda item No. 3: To discuss and decide on the tentative date for holding the long overdue 16^{th} Convention of the Federation after due consideration of all the attendant factors including identification of venue by the SCS Association volunteering to host the Convention:

Discussion: Secretary General apprised the House of the Rajasthan Administrative Association's offer to host the Convention of the Federation but they have not been able to host it because of certain unforeseen developments in their State; however, in absence of any representative from Rajasthan Administrative Service Association in today's meeting, even though the President of RASA assured that a representative from their Association would attend, it was difficult to ascertain their present stand. The Chair reiterated that the Convention, being long overdue, should be held without any further delay. Both the Secretary General and Finance Secretary endorsed his views.

Decision: After threadbare discussion, all the SCS Associations were requested to explore if any one of them could host the AIF Convention sometime in April 2020 and intimate the same to the Secretary General/ Finance Secretary latest by 31 January 2020 so that further steps could be initiated in this regard. It also emerged during discussion that the North Eastern States including Sikkim could explore if they could jointly host the Convention. Developments in this regard will be reviewed in the next Executive Committee Meeting to be held in Bengaluru and a specific decision taken after due assessment of the ground realities.

Agenda item No. 4: To deliberate on the present status of the Memorandum submitted by the AIF to the Hon'ble Prime Minister of India and to decide on the question of submission of a fresh memorandum cataloguing issues considered appropriate for inclusion in the changed perspective. A copy of the Memorandum earlier submitted to the PM marked Annex-A is attached; **Discussion:** Secretary General apprised the House of the steps taken by the Federation over the years to press the demands of the Federation at different levels of the Government- both at the Centre and the States- and the outcome thereof to the benefit of the SCS. He also mentioned that AIF always stands committed to protect, preserve and promote the interests of the SCS with all the might at its disposal in partnership with the SCS Associations across the country. Secretary, Finance discussed each of the issues highlighted in the Memorandum submitted to the Government of India with reference to their contemporary perspective and their evolution with the passage of time. The House eloquently appreciated the efforts of the Federation and its functionaries for doing full justice to the aspirations of the SCS all over the country and assured their unstinted support and whole hearted participation in the activities of the Federation in every manner to strengthen its efforts to promote the cause of the SCS.

Decision: After detailed deliberations, the decisions taken have been catalogued in in the enclosed **Annexure-A**. In absence of any further suggestions having been received except from Mizoram and Nagaland, who appreciated the charter of demands prepared by the Federation, it was decided to categorise the charter of demands into two distinct categories.

Issues to be taken up by the Federation:

- 1. Increase in the promotion quota of SCS to IAS from the present 33.1/3% to at least 50% of the cadre posts.
- 2. Scrapping of Rule 8 (2) of IAS Recruitment) Rules, 1954 and IAS (Appointment by Selection) Regulations, 1997 as neither special circumstances exist nor is there any exigency to recruit Non-SCS officers as the officers of outstanding merit and ability, having even more than 20 years of substantive service belonging to SCS, are available in good number for promotion.
- 3. Inclusion of leave reserve component of IAS cadre strength for the purpose of calculating promotional post of SCS officers to IAS.
- 4. Suitable amendment to Rule 3(3) (iii) of IAS (Regulation of Seniority) Rules, 1987 to allow the SCS officers promoted to IAS, seniority of four years for first eight years of service in SCS and one year for each completed year till the year in which he is considered for promotion.
- 5. Constitution of a National Commission for in-depth study of the problems afflicting the SCS officers and to hammer out solutions thereof in the national interest and to bring about uniformity in Pay & Allowances, Recruitment Procedure, Training, Promotional avenues, Service Rules, Cadre Composition, Cadre Management etc. for them throughout the country.

Issues to be taken up by the State Associations with active guidance of the Federation:

- 1. Advice to the State Governments for maintaining uniform pattern in fixation of cadre strength of IAS and SCS in the ratio of not more than 1:1.5.
- 2. Directions to the State Governments for filing up State Deputation Reserve Posts in excess of 25% of the cadre posts from the SCS officers instead of from the IAS as these excess posts are created by the State Government(s) for a temporary period.
- 3. Holding of annual meeting of Departmental Promotion Committee (DPC) at regularly for preparation of Select List of SCS officers for promotion to IAS so that eligible officers do not have to stagnate in the queue indefinitely.
- 4. Advice to the State Governments for opening of parallel channel of promotion for SCS offices in case they are not promoted to the IAS after eight years of qualifying period as a measure to arrest and contain the acute stagnation in the SCS.
- 5. Advice to the State Governments for introduction of uniform structure of pay and allowances to the SCS officers at par with those of IAS in the context of the acceptance of the recommendations of the Seventh (7th) Central Pay Commission by the Government of India.

Agenda Item No. 5: To discuss and deliberate on the State-specific issues as shown in the attachment marked Annex-B;

Discussion: Secretary, Finance informed that the issues of other states could not be included in **Annexure-B** as no information in format A-E (both inclusive) had been received. It is imperative that the importance of formats A to E (both inclusive) is properly appreciated in the best interest of the SCS officers of the respective States.

Decision: (i) Eighteen States listed in Annexure-B, are required to inform the Secretary, Finance in case they want any other issue listed.

(ii) Other State Associations are required to furnish detailed duly updated information in Format A-E as already mailed to them to the Secretary, Finance without any further delay taking **01-01-2019** as the cutoff date so that the issues listed could be included in the **Annexure-B** and discussed in the next meeting of the Executive Committee.

(iii) The State Associations are also required to take up their issues with the respective State Governments. In case they need any guidance from the Federation, they should flag the same with the Federation for appropriate decision.

Agenda Item No. 6: To discuss and deliberate on the efforts made by DANICS, UPCSA and the SCS Association of Haryana on the issue of facilitating allotment of land for construction of AIF Office in or around Delhi:

Discussion: No representative from DANICS was present in the meeting on date. The representative of UPCSA was also absent. As such, no feedback was available. However, both the President and General Secretary of Haryana Administrative Service Association participating in the discussion volunteered to explore all possibilities for realisation of the long felt need of the AIF.

Decision: Haryana Administrative Service Association shall take up the issue with the State Government of Haryana. They were requested to consult Secretary, Finance, AIF and collect necessary inputs in this regard. They were further advised to keep him posted with further developments in the matter so as to enable him to enlighten the members on the updated status in the next Executive Committee meeting of the Federation.

Agenda Item No. 7: To brainstorm on the best practices of the SCS Associations across the country as per details shown in the attachment marked Annex-C and to identify further actionable points.

Discussion: Secretary, Finance informed the house that information in Annexure-C has been compiled on the basis of information received from the representatives of the SCS Associations attending the Executive Committee meeting of the Federation held on 16^{th} September, 2017.

Decision: The SCS Associations of the States of J&K, H.P, DANICS, T.N., Andhra Pradesh, Kerala, Telangana, Jharkhand, Odhisha, West Bengal, Gujarat, Goa, Maharashtra, Chhattisgarh, M.P., Uttarakhand, Arunachal Pradesh, Assam, Meghalaya, and Sikkim shall inform the AIF (Secretary, Finance) of the best practices in their respective States in exclusion of those already mentioned in **Annexure-C** for preparing a comprehensive document on the subject and to disseminate the same to all the SCS Associations after discussion in the next Executive meeting of the Federation slated to be held in Bengaluru.

AGENDA: PART II: FINANCIAL ISSUES

Agenda Item No. 1: To discuss and deliberate on the status of outstanding Affiliation Fees payable to AIF by the SCS Associations with reference to the mail of the Finance Secretary of the AIF to the SCS Association dated 13 December 2019 to clear the dues;

Discussion: Secretary, Finance informed that Karnataka, Nagaland, Haryana, Arunachal and Himachal

Pradesh have cleared their outstanding affiliation fees while part payment on behalf of Chhattisgarh & Bihar has also been made.

Decision: The remaining State Associations were advised to pay the outstanding fees as mentioned in **Annexure-D**, on or before 31st January, 2020 by depositing the same in the name of Federation (All India Federation of State Civil/Administrative Service Associations), A/C No. 06810100003746, IFSC Code: BARB0KARNAL.

Agenda Item No. 2: To place the Expenditure Statement(s) of the AIF for the year 2017-18 and 2018-19 for approval of the House.

Decision: After detailed discussion, the House approved the Receipt and Expenditure Statement of AIF for the year 2017-18 & 2018-19 as tabled and explained by the Secretary, Finance, AIF.

Agenda Item No. 3: To discuss the status of implementation of the recommendations of the 7th CPC by the State Governments and to review the present position with respect to the submission of uniform proposals by the SCS Associations to their respective State Governments based on the common template made available to the SCS Associations by the Finance Secretary of the AIF via mail:

Discussion: It was informed by the Secretary, Finance, that as per Format-B, the State Governments of Haryana, Karnataka, Bihar and Arunachal Pradesh have allowed pay scales in the context of acceptance of the recommendations of the 7th CPC. Inputs from the rest of the States were unavailable even though duly articulated proposals from AIF following discussion in its Executive Committee meeting to all the SCS Associations have been sent as early as in 2017.

Decision: On due scrutiny of the information received, it was resolved that:

- (i) Haryana Administrative Service Association shall again take up the issue with the State Government for revision of the Pay matrix (level-13) from Rs. 118500 to 123100, as already revised by the Government of India besides other scales on the lines drafted by the Federation and handed over to all the participants in today's (4th January 2020) meeting.
- (ii) First three levels (10, 11 and 12) granted by the Government of Karnataka are higher in comparison to the ones recommended in the 7th CPC but the next two levels (13 and 13A) are far below. As such, Karnataka Administrative Service Association should do well to parley with the Government for consideration of the proposals on the lines drafted by the Federation.
- (iii) In case of Arunachal, level-11 has got to be rechecked and conveyed to the Secretary , Finance if it is 51700-208700 or 67700-208700, and regarding level-13, whether it is 130100-215900 or 123100-215900 and in case of level 13A/14 whether it is 131100-216600+1000 or 144200-218200. The State Association should take up the issue with the State Government given the uniformity of the proposal.
- (iv) Other SCS Associations are also required to take up with their respective State Governments in the matter of implementation of the 7th CPC recommendations on the suggested lines and apprise the Secretary, Finance of the outcome in due course.
- (v) A copy of **Annexure-E** in respect of uniform proposal is attached for necessary action

Agenda Item No. 4: To discuss and deliberate on the issue of allowing two additional increments to the IAS officers promoted from the SCS in different States in Junior Administrative Grade and Selection Grade prior to 31^{*} December 2016 and to explore avenues to protect the interests of those SCS officers promoted to IAS. President/General Secretary may please collect copies of the relevant Government

orders allowing additional increments, if any, to such promote officers and place the same in the meeting:

Discussion: In spite of the fact that the issue is very important for the SCS officers, none of the Associations present could throw light on the action taken by the State Government concerned to address the issue to the benefit of officers promoted to IAS from SCS in their respective States.

Decision: All the State Associations were requested to inform the Secretary, Finance, on this issue by 31st January, 2020 so as to enable him to place the matter in the next meeting of the Executive Committee for taking a suitable decision.

Agenda Item No. 5: To discuss on the present status of submission of the data by the SCS Associations as per Formats A-E to the Finance Secretary, AIF, for updating the AIF's Data-Bank. Ref. Mail of the FS,AIF dated 13th December 2019:

Discussion: Secretary, Finance informed the house that 17 states have furnished the information in Format A-E during the last 10 years or so and, that too, after repeated persuasions. The updated information as on 01.01.2019 have only been furnished by the SCS Associations of Himachal, Karnataka, Jharkhand, U.P. Arunachal Pradesh, Mizoram, Meghalaya and Tripura. He also said that the accuracy of some of the information furnished needs further verification.

Decision: The SCS Associations of DANICS, J&K, Andhra Pradesh, Kerala, Telangana, Odhisha, West Bengal, Goa, Assam, Manipur, Meghalaya, and Sikkim shall furnish the information in Format A-E (already mailed to them) to the Secretary, Finance, AIF.

State association of Haryana, Punjab, Tamil Nadu, Bihar, Gujarat, Maharashtra, Rajasthan, Chhattisgarh, M.P. and Uttarakhand shall also furnish updated information as on 01.01.2019 in format A-E.

Agenda Item No. 6: Any other agenda with the permission of chair.

No another agenda item was taken up.
